# A WORD FROM THE EXECUTIVE PRESIDENT (CEO)

It is under serious lockdown that I write this foreword. AJESH's Coordinating office and field offices are locked up. The closure of our doors does not in any way mean we are out of work. The COVID-19 has given us a different sense of direction as AJESH has instead gone more robust than ever to tackle the unprecedented impacts of the global pandemic.

In retrospection to 2019, it seems like a year with so much happenings and challenges to communities that we serve and to the staff of AJESH. Indeed, it was a year of instability and civil unrest. City by city, village by village, people in the North West and South West Regions of Cameroon came onto the streets to protest rising inequality, stretched social services, a deficit of trust and a damaged climate which serious armed conflicts heightened into between the regular army and groups of Non State Armed Groups (NSAGs). Today, a few short months into 2020, the streets has further metamorphose, and life has changed utterly for billions of people in Cameroon, Africa and the world at large with the advent of the COVID-19 pandemic.

However, the year 2019 has not always been a rosy one for AJESH. The organization has been



faced with a drastic decline of its business volume in certain areas of intervention affected by the insecurity and instability that are also the image of the World over the last few years. Such a situation inevitably calls for backup strategies to consider for the future.

Last year, despite the socio-political upheaval and climate challenge effects, AJESH worked hard to support the local communities across Cameroon to sustainably manage their natural resources, practice ecofriendly agriculture and managed their health challenges. We continued to push beyond limits, reflect, deliver, invest and manage to deliver on our Strategic Plan, establishing AJESH's financial stability and taking steps to make the organization nimbler and more responsive. Today, as we extend our support to other parts of Cameroon and Africa, our initiatives are gaining grounds.

In 2019, AJESH demonstrated the importance of community participatory mapping and land use planning as a veritable tool in the economic growth of a country with the development of the land use planning methodology accepted by the ministry of economy, planning and regional development (MINEPAT) Cameroon. Our successful implementation of community mapping and land use planning activities over the years in the south west region of Cameroon is an illustration.


AJESH's efforts in supporting natural resources eco-friendly management, promotina agriculture and improving local community wellbeing has improved people's interest in land and natural resources management and has led to informed decision making in target communities. Specific interest was guided towards community's effective protection of their land rights. This has given rise to emerging community awareness on the need to actively participate in lives impact activities as well as take ownership of natural resources development programs. In attaining this, the community's livelihoods and health was equally improved.

Also, we are fortunately. We should point out that in 2019, AJESH hosted some interns as part of our strategy to provide hands-on training opportunities for young Cameroonian graduates. We were able to support two of our staff in the pursuance of their PhD with thesis defense planned for 2020.

AJESH was also able to secure an additional office space in the town of Limbe to facilitate working collaboration with partners who may not be able to visit the coordinating office in Kumba as a result of the crisis mentioned above. The headquarters building has also been renovated. All this is part of the will of the Coordination to improve the framework and working conditions of the staff that we consider to be our main factor of production.

The successful implementation of the strategic interventions amidst the loud guns and the unstable environment was as a result of the commitment, support and collaboration from our staff, the Administration, consultants and partners.

# **IMPLEMENTATION OF PROJECTS/PROGRAMS IN 2019**

Presently, AJESH is running projects in Cameroon with focus on different aspects of rainforest protection, community land rights and community wellbeing. Be it providing technical training or raising awareness or providing material/financial support, all our projects are based on a participatory approach that puts local people at the heart of what we do in harmony with the environment.

Sustainable Management of Natural Resources

#### Land Governance

# a. Community Participatory Mapping

In 2016, MappingForRights was recognised by the UN Framework Convention on Climate Change (UNFCCC) as part of the UN Momentum for Change awards. AJESH shared award with RFUK as MappingForRights implementing partner. It is an interactive community map project for the Congo Basin, which started in November 2011 and is ongoing.

By highlighting the presence of otherwise 'invisible' indigenous peoples and forest communities, this project bridges the gap between remote forest communities and central decision-makers, view the aim of eradicating the marginalisation of forest dwellers.

Our mapping activities has gone way over the MappingForRight project as we have supported hundreds of forest and coastal communities across Cameroon to produce maps of their lands and resources covering over 1.5 thousands hectares.

Some of our achievements on community participatory mapping in 2019 include:

- Continuous coaching of trained community mappers on map interpretation and how to integrate information in Communal Development Plans.
- Over 18 neighbourhoods within Kumba 1 sub division were mapped over



representing a total area of about 250km<sup>2</sup> of land cover.

- Trained over 15 council personnel on community-based tenure management
- The mapping data developed is now used in policy discourse to integrate into landuse planning processes, REDD+ initiatives processes and to track and mitigate impacts of potential agro-industrial expansion in the South West Region



large and growing membership base among key stakeholders to defend the rights communities. of local Collaborating with RFUK in pioneering geo-spatial new technologies and mapping methodologies, bridging the gap between remote forest communities and central

decision making processes.

 AJESH is also supporting communities and civil society colleagues to engage in land governance actions, to ensure that indigenous and community rights are respected and in line with international standards, such as Convention 169 of the International Labour Organisation (ILO) on "indigenous and tribal peoples" (1989), ratified by CAR in 2010.

- Trained 18 women and youth on advocacy approaches and use of advocacy tool to negotiate livelihood lands from traditional administration.
- Updated community maps of 4 villages (Ekenge, Mboka, Njunue and Nsonglu), within Nguti landscape.
- b. Land Use Planning

From 2015 through 2019, AJESH has been rainforest supporting communities in Cameroon to achieve long-term, sustainable development by gaining greater control over their traditional lands and resources through participatory land use planning.

AJESH, and partners



commenced two ambitious land use planning pilot, building on a wealth of participatory maps created by local communities through the MappingForRights initiative. The project has since tested participatory land use planning exercises in Nguti Sub Division, Southwest Region of Cameroon.

Starting at the village level, we are worked with local communities to develop rigorous, people-centered methodology that can be scaled-up to higher levels.

At the council / municipal level, we are working with the council administrative and technical departments in developing inclusive and integrated people-centered methodology that informs the regional and national zoning plans.



The participatory mapping work in Nguti Council Area, in the South-West region, marked the first time all the communities in a single administrative unit were supported to map their lands. This however set the stage for AJESH to continue the support to clans in the area to produce their land use plans and to set up

community structures for land use planning. Within the year 2019 results obtained include:

- AJESH in collaboration with LTs. International, Rainbow Environment Consult SARL and the Ministry of Economic and Planning (MINEPAT), with funding from EFI (European Forest Institute) are led the development of a national council level land use planning methodology for Cameroon adopted by the different sectorial ministries and development partner February 2019 at Mont Febe Yaounde.
- Raised awareness of over 80 people across Cameroon (administrator, Development programs, council administrators, .....) on the importance of local level land use planning in a workshop organised in Garoua.
- Continued education and coaching of 18 community and 3 clan land use planning committees in the south west region of Cameron.
- Our community land use planning activities is been used to orientate the national harmonized council level land use planning and the communal development plans (CDPs).
- Elaborated the communal development plan for Nguti and Kumba 1 councils.
- Organised regional and local workshops on Participatory Land Use Planning reached over 450 people of mixed sex.

#### Forests Governance

Our work on forest governance aims at increasing community involvement in decision making in the management of natural resources relevant to the protection of the forest and wildlife in view to alleviate poverty and contribute to the development of equitable, transparent and sustainable forestry and wildlife management that will improve governance and livelihoods for forest communities.



With financing from our donors and partners, we are supporting local communities to understand the forestry law as well as international conventions on forestry, wildlife and climate change rectified by the government of Cameroon for a better understanding of their property rights and benefits over the resources of their customary forests.

In partnership with other organisations involved at national level with independent forest



monitoring, AJESH continuoured to carry out independent illegal monitoring of logging activities in and around logging concessions in the Southwest, Littoral and Eastern Regions of Cameroon. In addition, we monitor the the non-respect and implementation of social engagement between companies

and communities within the forestry sector. This included:

- Researched on community's involvement in the management of Forest Management Units (FMUs) and Sales by Standing Volumes (SSVs) in logging concessions in the South and East Regions in Cameroon.
- Mobilized and trained 10 Village Forest Management Committees (VFMCs) to participate effectively in the management and follow up of Forest Royalties in logging concessions as well as play their role in the management of Protected Areas (Pas).
- Build the capacities of VFMCs on participatory forest governance.
- We supported the organization, reorganization and built the capacities of forest community's governance structures (Village Forest Management Committees -

VFMCs) in and around logging concessions and protected areas in the South West Regions of Cameroon for effective participation in the management of forest and wildlife affairs in their communities.

- and wildlife activities in and around forest concessions managed in the littoral region precisely in the Yabassi-Loum-Nkongsamba axis of Cameroon.
- Mobilised the Ekenge and Mboka community towards acquisition and sustainable management of community forests reserves as a way to enhance their customary and user rights.

# Climate Change

Cameroon joint the world at large in the fight against climate by being a signatory to the <u>conference for the United Nations Framework Convention on Climate Change</u> (UNFCCC) and the Kyoto Protocol and regularly participated in the Conferences of the Parties (COP).

During the 21<sup>st</sup> UNFCCC, Cameroon announced its ambitious commitment. These commitments perfectly align with the country's desire to be emergent by 2035 and the urgent need to save the planet from environmental destruction.

Within this framework, AJESH is contributing to government's implementing credible efforts towards the fight against climate change in Cameroon. This has been through different sectoral ministerial (agriculture, forestry, environment and nature, waste management, construction, transport, and industrial development) plans and measures that are both innovative and encouraging in their various sectors of activities geared towards implementing REDD+ initiatives.

- AJESH, other civil society stakeholders and the Cameroon Government with funding from the EU REDD Facility (EFI) are supporting the implementation of the land-use planning law at local (municipal) level. The aim is to increase transparency and information sharing in land-use planning and land allocation processes. Actions realized include:
  - land-use planning at local level (the Common Mapping Platform and the Land-use Planner) tools developed, and
  - a methodology for municipal land-use and sustainable development plans developed. The methodology has been adopted by the Ministry of Planning, Economy and Regional Development to support municipalities facing land conflicts and increasing pressure on natural resources.



• Researching, sensitizing and training communities and other stakeholders on the **BIOCHAR** technology. Plant and animal material turned into charcoal to store carbon—is highly proposed as a **climate** mitigation strategy. To avoid the worst consequences of **climate change**, we need to significantly reduce global

warming emissions and if possible remove existing carbon dioxide from the atmosphere.

- Supported the elaboration of ecofriendly communal development plans (CDPSs) for councils (Nguti and Kumba 1) and orientating council development officers on climate change adaptation and resilience approaches in the implementation of council development projects in their respective municipalities.
- Continued capacity building of civil society actors and community members on climate change mitigation, adaption and resilience approaches. Over 60 community people and local CSOs were reached with messages on REDD+ in 2019.
- Carried out sensitisation on collaborative management of protected areas with communities around Protected Areas (Korup National Park, Bakossi National Park, Takamanda National Park, Banyang Mbo Wildlife Sanctuary, Nki National Park, Mt. Cameroon National Park, Proposed Mt. Kupe and Muanenguba reserves,......) in Cameroon.



Supported communities and councils with training and follow up tools in the sustainable and ecofriendly management of community and council forest reserves. This is further buttress with organizing community structures and governance building their capacities on their roles and responsibilities in the management protected areas taking into account climate change mitigating approaches.

 Trained 25 agricultural cooperatives and farmers on ecofriendly agricultural production practices (CLIMATE SMART AGRICULTURE), thus promoting zero deforestation cocoa production and on zero deforestation food crop cultivation

- Supported maritime communities along the Bakassi coastline (Isangele, Idabato,
- Kombo Abedimo, Kombo Itindi and Bamusso) of Cameroon in the practice of ecofriendly fishing.
- Carried out community participatory mapping of the coastal landscape of the Bamusso, council area as a tool to strategically plan and orientate fishing activities and for the regeneration of mangroves along the Bamusso\_Bekumu coastline.



- Some communities within Nguti Sub division were supported on using their maps to negotiate community rights in Council management plans and the Southwest regional jurisdictional REDD+ pilot Emissions Reduction Program.
- Supported sustainable NTFP Value Chain Practices. This include the promotion of NTFP domestication and creation of market linkages.
- Promoting municipal tree planting activities with focus on landscape management to reduce erosion and siltation of water basins in and around mountain (Lake Barombi, Mt. Kupe, Mt. Muanenguba, Mt. Cameroon) and lowland areas of the Southwestern Cameroon.
- Supported 5 village communities to actively participate in climate change related activities in Bamusso and Isangele council areas.
- Promoted reforestation and afforestation programs with Limbe 3, Mbonge and Kumba 1 councils and other villages around the Southern Bakundu Forest Reserve and the Barombi Mbo Lake reserve.

# SUSTAINABLE AGRICULTURE

The development of Cameroon depends on agriculture, the economic sector which currently generates 23% of gross domestic product and employs 62% of the population.

Today, national strategy to bring about agricultural progress includes the experimentation of genetically modified organisms (GMOs), which Cameroon intended to commercialize by 2019.

There is lack of access to adequate amounts of safe and nutritious food which is a public health concern worldwide and particularly in Cameroon. Due to its agro-ecological diversity, Cameroon has great potentials for agricultural production to contribute towards its over 23 million people and beyond, thus contributing towards feeding the world's 9 billion people. Until the late 80s, Cameroon was considered self-sufficient in agricultural production and played a role of food garret for its neighbouring countries. Since early 90s, Cameroon began spending billions of francs CFA to import large quantities of food items (rice, maize, onion, tomatoes, milk and poultry) even though relying on national products has a clear comparative advantage. This has been very worrisome as it undermines local production potentials and pushes many producers out of the production chain as a result of unfair competition.

The challenges are numerous (but not impossible) including low levels of input e.g. via governments subsidies as well as the expected adverse impact of climate change on agriculture now and in the future.

Agriculture has equally been tagged as the key drivers to deforestation and degradation

with the consequences being the adverse climatic changes.


AJESH therefore come in to contribute in ensuring that the ecosystems are protected while promoting ecofriendly agricultural order practices in to reduce deforestation and forest degradation by ensuring the livelihoods of the farmers are improved. On this note, AJESH carried out activities on sustainable agricultural systems and food crop productivity in 2019 by implementing the following action:



- Educated 80 farming families on sustainable ecofriendly agricultural production practices.
- Promoting Income Generating Activities (IGA) and small scale agricultural business for farmers by assisting needed vulnerable families with start-up incentives.

- Promoted the Value Chain Development of both food and cash crops for local and small scale holder farmers in Kumba and Tombel.
- Build the capacities of 5 cooperate farmers on ecofriendly agricultural practices.
- Educated 5 cocoa cooperative on the necessity of practicing and producing Zero deforestation cocoa.

Carried out studies



production, processing and marketing of food crops in the Southwest and Littoral Regions of Cameroon.

on

- Supported communities and over 10 farmers groups with improve and disease free planting materials (maize seeds, cassava cuttings and pepper seeds).
- Facilitates the establishment of 2 demonstration farms and seed multiplication centres for farmer cooperatives.

# **COMMUNITY HEALTH CARE**

#### Humanitarian Actions

Cameroon is faced with socio-political crisis, this current crisis heated up in 2016 when activists in Cameroon's South and North western regions protested the predominant use of the French language in institutions within the Anglophone regions. This is an expression of deeper, long-held grievances around good governance and equitable political and social representation, what started as a struggle for equality and justice by

citizens of these regions has spiraled into a full-blown crisis. Armed groups seeking an end to what they consider domination of the Anglophone south by the francophone north have risen against the government's security forces that has led to the killing of hundreds of thousands of people and the displacement of others from their homes.

Factories have been shuttered, roads have become impassable, warehouses have been destroyed, and truck drivers and other persons are routinely kidnapped for ransom. "Fighting has intensified in the so-called Anglophone regions between security forces and armed groups.

These regions have been affected, in the last few years, by crises which have caused great insecurity on many fronts, challenging vulnerable communities such as women, children, and the poor – many of whom live in bushes and marginal lands with their livelihood sources threatens, this has led to increased hunger and food deficiency related diseases (malnutrition). In this atmosphere of insecurity (physical, food, hygiene, and health), sexual and gender based violence is prevalent and social cohesion between various groups is threatened.

Key problems addressed by AJESH includes: lost and threatened livelihood assets that have led to serious malnutrition, low income, etc. and unsound waste disposal practices among families and groups. As such through 2019, AJESH carried out the following actions:



- Built the capacities of groups/communities especially women, youth, the elderly and the disabled groups in rebooting the income generating activities of some Internally Displaced Persons (IDPs),

- Facilitated the semi restoration of rural agricultural infrastructures e.g. cocoa ovens, installation of processing units etc.

- Supported IDP host community initiatives for immediate income generating,
- Organied workshops on building trust through creating space for intercommunity dialogue to ensure peace in their communities.
- Built the capacities of women, youths and physically challenge individuals and groups to source ways to restore their livelihoods and improve social cohesions and dialogue between and amongst themselves within the crisis striking areas.

In partnership with the Norwegian Refugee Council (NRC), AJESH implements some additional humanitarian activities amongst which them was a life-saving emergency assistance project to displaced populations in the southwest and northwest regions of Cameroon funded by: Norwegian Ministry of Foreign Affairs



(NMFA), Global Affairs Canada (GAC) and Office of Foreign Disaster Assistance (OFDA). The following action were carried out:

# WASH



For the hygiene promotion, some of the key activities include;

- Assessment of the population that use safe water for drinking through a structured questionnaire;

- Monitoring whether the environment is free of fecal matter and;

- Establishing the proportion of the population having knowledge on the critical hand washing times through a structured questionnaire;

- Uploading the data into Kobo system

which will be provided to NRC to enable analysis;

- Conducting hygiene promotion sessions to benefit 5,000 displaced persons under project a using structured IEC materials and partner trained on their usage;
- Sensitization on alternative methods to soap to the populations to enable them continue with good hygiene practices even in case of absence of soap.

# Non Food Items (NFI), shelter kits and hygiene kits distribution activities

The key activities that will be undertaken include:

- Assessment of the population in need through a structured questionnaire;
- Selection and registration of beneficiary stakeholders.

- Enter data into NRC format and submission of the data in soft copy for verification;



- Distribution of the NFI's to the beneficiaries with the verified list;

- Monitoring the NFI distribution process to track progress and delivery of the shelters kits;

- Establishing the level of satisfaction of the beneficiaries through a post distribution monitoring exercise, with the NFI distribution and monitoring the use of the NFI kits

provided;

- Profiling of women and girls of childbearing age (15-49 years);
- Distribution of Menstrual Hygiene Kits (packs of sanitary towels).

# Food Security and Livelihood

There are possibility of some Food Security and Livelihood assessments for potential intervention.

Preventing Malaria, HIV/AIDs, etc. in Communities

As a continuous process in partnership with the ministry of Public health under the Global Fund Funding Mechanism in Cameroon to fight AIDS, Tuberculosis and Malaria; ensuring consistent integration of community activities of the three Programs namely National Malaria Control Programme (NMCP), National AIDS Control Committee (NACC), and the National Tuberculosis Control Programme (NTCP). AJESH in fidelity advances with the implementation of "Achieve and Maintain Universal Coverage of Interventions to fight Malaria for Long-term Impact" abbreviated AMCUID.

In collaboration with the personnel of Public Health, Plan Cameroon and IRESCO, AJESH works to facilitate the implementation of the harmonized community intervention strategy whose goal is to ensure that at least 80% of the population adopts conducive practices to

the promotion of healthy behaviours, the prevention and integrated management of diseases (Malaria, Acute Respiratory Infections, Diarrhoea, Tuberculosis, HIV/AIDS, Malnutrition, Onchocerciasis, Vaccine-Preventable Diseases, etc.) including combating violence and promoting FP at community level, especially in priority intervention areas.

• Within this program, AJESH is covering four (04) out of the selected Seven (07)



Health Districts in the South West Region and is tasked with facilitating the implementation of Community Based Interventions in these districts which involves overseeing the day to day activities of Community Health Workers in their respective communities. In order to intensify the awareness in communities on the use of Long Lasting Insecticidal Nets as a means to protect them from malaria which has been the number one killer

disease in Cameroon over decade's, AJESH through its community workers carries out series of educational activities with the support of the state health personnel working at the health districts and health Area Levels. Realisations include:

- Continued training of over 250 CHWs in Konye, Ekondotiti, Nguti and Tombel Health districts on the context of the project < Achieve and maintain universal coverage of interventions for the fight against malaria for long term impact> (AMCUID).
- Recruited and training new CHW agents for konye, EkondoTiti, Nguti and Tombel health Districts to replace the inactive ones.
- Continued revision with CHW the process on BCC, Advocacy, Counseling, home visit, diagnosis of uncomplicated malaria, educational talks, refer cases of early

malaria, tuberculosis, HIV/AIDS and pregnant women to the hospital (for ANC) etc. These CHWs work directly with the community people counseling them in their homes, groups, during clinical sessions, and during public gathering such as national days, cultural festivals, etc. on malaria control and prevention, tuberculosis, and HIV/AIDS.

- Distributed CHW working materials in all the health districts and did put at their disposal first aid drugs for minor cases.
- Carried out monthly and quarterly supervision of all trained CHWs in the four health districts covered by AJESH.
- Did administration of medication to uncomplicated malaria patience in hart to reached communities with no functional health facility.
- Carried out bimonthly home visits and onsite data verification all the Health Areas within health districts covered by AJESH, and encouraged household members on the usage of their nets, diagnosed cases of complicated and uncomplicated malaria and reported to the nearest health facilities for follow up of patients. Carried out advocacy action on Behavioral Change on health related matters.
- Contributed to the follow-up on the use of mosquito nets.

- Gross administrative bottlenecks.
